

# 2010 Miniatures Art Exhibition & Sale

## Conditions of Entry

- 1 Miniature art works must be A5 (15cm x 21 cm) size or smaller. Frames can be bigger than A5 size.
- 2 There will be one 2D miniature category for artworks of any medium.
- 3 All entries must be the original, bona fide and unaided work of the entrant.
- 4 All artworks must be in a form suitable for hanging. Artworks without suitable hanging apparatus will not be exhibited.
- 5 The entry fee is \$10 for up to 3 entries and \$5 per entry after that. The **completed entry form and payment are due no later than Friday 23<sup>rd</sup> April 2010**. Send to: Louise Gronold, Exhibition Coordinator, PO Box 144, Barcaldine, Qld 4725.
- 6 Each entry must be clearly marked on the back with the entrants Name & Address, Title and Selling Price.
- 7 All entries must be for sale. The Exhibition organisers will retain a commission of twenty per cent (20%) on all sales.
- 8 The Committee will endeavour to hang all artworks entered.
- 9 All **art works are due by Wednesday the 28<sup>th</sup> April 2010** and must be available for hanging for the full duration of the exhibition 30<sup>th</sup> April – 3<sup>rd</sup> May 2010.

- 10 Artists shall allow their work to be reproduced in the media (without fee) for promotion of current and future Barcaldine Art Competition and Exhibitions.
- 11 All artworks can be addressed to Louise Gronold, Exhibition Coordinator, via post PO Box 144 **OR** freight 51 ASH STREET, BARCALTINE QLD 472.
- 12 All expenses of, and in connection with forwarding, packaging and insurance of artworks shall be borne by the Entrant. Artists are advised to ensure their artwork is properly packaged to avoid damage during transit. Return freight will be at the Artist's expense and must be received with entry form or Art works.
- 13 All artists are responsible for insuring their own work for the duration of and during transport to and from the exhibition.
- 14 Any prints entered in the exhibition must bear the appropriate edition and number of impressions.
- 15 Where the entrant is registered for GST, the stated sale price must be GST-inclusive and ABN must be supplied.
