Vehicle and Safety Requirements

Purpose built race vehicles and cars quicker than 10.99 (1/4 mile) / 7.00 (1/8 mile) must comply with the relevant ANDRA Class and Safety regulations pertaining to the vehicle. All entrants must be fully licensed for the vehicle and vehicles must have a current technical Inspection.

Other entrant requirements:

- Licence
 - Divisional ANDRA Day Licence will be issued to those who do not need to hold a permanent ANDRA Drag Race Licence.
 - You must hold a current civil drivers licence.
- Protective Clothing
 - Helmets. All vehicles SLOWER than 7.00 seconds (1/8 mile) helmet to AS/NZS 1698:2006 (AS/NZS 1698)
 - Drivers - Long sleeved upper garment, full length trousers, shoes and socks as a minimum
 - Riders – Long trousers, a securely fastened leather jacket, full leather gloves and closed footwear as a minimum, all bikes require a chain guard
- Your Vehicle
 - Ensure all fluids can be contained within the vehicle
 - Mufflers/Muffling devices required for vehicles SLOWER than 7.00 seconds (1/8 mile) as per ANDRA guidelines
 - Tail shaft loops required for cars running QUICKER than 8.30 seconds (1/8 mile)
 - Minimum 3 point lap sash for cars SLOWER than 7.70 seconds (1/8 mile)
 - Minimum 4 point harness for cars QUICKER than 7.70 seconds (1/8 mile)
 - Roll bars are required for open cars 7.05 – 8.35 seconds (1/8 mile)
 - Open cars quicker than 7.05 seconds (1/8 mile) must have full roll cage relevant to ANDRA specifications.

AIRPORT SAFETY - please all competitors note the site plans and Airport reporting Offices at the track in 2011 and be directed by them.
